Directions Regarding the Use of Facilities at the Dapeng Bay Marina

- 1. The Dapeng Bay National Scenic Area Administration, Tourism Bureau, Ministry of Transportation and Communications (hereinafter referred to as the Administration) has formulated the following regulations in order to maintain order and safety at the facilities within the Dapeng Bay Marina, to facilitate the berthing of ships and the embarkation/disembarkation of passengers.
- 2. The detailed location of the Marina area (hereinafter referred to as the berthing area) referred to in these regulations is shown in the attachment.
- 3. Applicants for berths must submit an application to the Administration for review in accordance with the "Key Points for Leasing Berths and Facilities at Dapeng Bay Marina". Those who pass the review must pay berthing and other fees in accordance with the regulations. Those who fail to pay such fees in the allotted time period shall be deemed to have given up their berthing rights.
- 4. When a ship enters the waters of Dapeng Bay, the maximum sailing speed is 10 knots, and 5 knots (9.26 km/h) in the berthing area. If the facilities in the berthing area are damaged or casualties are caused by wave-making or improper operation of the vessel, the owner will be deemed responsible for compensation and related legal liabilities.
- 5. The following is not permitted in the berthing area without the permission of the Administration:
 - i. Tying cables to the wharf facilities beyond the mooring post of the berth.
 - ii. Failing to berth a vessel at its designated berth or changing places without authorization.
 - iii. Stacking objects, disposing of garbage or setting up facilities on floating trestles, main and branch walkways, or berthing areas.
 - iv. Carrying out vessel repairs, refits, or related use of workspace for improvements.
 - v. Engaging in activities involving incoming automobiles, motorbikes or related vehicles to replenish supplies. If the vessel owner needs such a vehicle to enter the berthing area, he/she must first receive approval from the on-site administrator, park in a designated location, complete replenishment, leave the berthing area within 10 minutes, and then park the vehicle in a designated parking area if parking is requested.
 - vi. Engaging in fishing, aquaculture, casting of nets, swimming, holding barbecues, smoking and other similar activities.
 - vii. Carrying out operations such as lifting and loading of ships.
- 6. Only the following personnel are permitted to enter areas other than the transportation ship wharf in the berthing area:
 - i. The vessel owner, vessel owner's representative, employees, and users.
 - ii. Individuals accompanying the vessel owner or a representative thereof.
 - iii. Others permitted by the department.
- 7. Discharge of waste water, damage to the environment, or other polluting behavior is not allowed in the berthing area. Violators will be dealt with in accordance with the Act for the Development of Tourism or other laws and regulations; Offenders will be responsible for clean up and liable for all related expenses.
- 8. When items occupy facilities in the berthing area in violation of the regulations, and improvements are not made after an announcement or notification from the Administration, they will be regarded as waste and cleaned up or removed in accordance with the Waste Disposal Act, with all related expenses charged to the responsible party.
- 9. In the event of the following, the department may implement restrictions in the berthing area:
 - i. In the event of land or sea typhoon warnings, severe weather, or special weather conditions such as dense fog that impairs navigation, after on-site observation by the meteorological authority the Administration may introduce controls at the wharf.
 - ii. If the wharf facilities are damaged or there are other safety concerns, the department may prohibit berthing.
 - iii. Other circumstances that cause the department to deem restrictions necessary.
- 10. Official or emergency rescue ships may berth in any vacant berth and board and disembark passengers when necessary, in the performance of official duties or maintaining safety, while following the instructions and dispatches of on-site personnel.
- 11. If these provisions are violated and no improvements are made at the urging of the Administration, or if the circumstances are serious by the party leasing the berth position, the Administration can terminate the lease agreement; in situations involving the relevant provisions of the Act for the Development of Tourism, the situation shall be handled in accordance with those provisions.
